

The World Train Wreck

It was inevitable that eventually the medical and food industries would run the world off its financial rails.

At some point the demand for free medical service of the latest technology by people infirm from eating engineered food was bound to break the economy. This has been obvious to me for some time, but the way it happened surprised us all. It was not the stress of costly drugs and medical procedures, and yet it was: it happened because treatment for a novel virus infection demands more ventilators than are on hand.

But the shortage is not ventilators exactly; it's shortage of technicians trained to operate them. The shortage of technicians is due to the extreme specialization that has completely remodeled the medical industry. The over-specialization is driven by technology which is fueled by money thrown at it by governments. The reliance on costly technology is protected by government-assisted rejection of non-patented medicine and the barring or discouraging of simple procedures that can be performed by non-specialists.

The demand for costly medical treatment is perpetuated in part by weaknesses in human health caused by modern medicine's success in extending lifespans. Perpetual need for medical attention to treat the side effects of unnatural medical treatments is another self-serving factor.

Only about 10% of hospital beds are in ICUs. The ventilators and their operating personnel seem to require the ICU arrangement. If the ventilator had not been invented, there would be no shortage of hospital capacity. If the medical experts had not frightened the world with their overblown predictions, there would not be the dread of coming near an infected body, and the normal means of handling the slight increase of corpses (a much smaller increase than is seen in a bad flu season) would not have broken down. There would be no need to flatten the curve, and there would be no train wreck.

The lusty profits in modern medicine enjoyed by its hospital conglomerates (which have developed immunity from monopoly laws) and drug developers, plus the “socialization” of medical revenue income, has catapulted the system from a service satisfying the needs of people moderated by their ability to pay, to a behemoth that was poised to dominate the economy. And it has done so quite suddenly, not by its overwhelming size but by severely wounding the economic body that supports it—like the overactive immune system in a human body causing death while reacting to a viral infection.

Once this train got rolling there was no way to stop it. Or, yes, there was a way, but the people in positions to make changes for sustainability in medicine had a larger vision. They believed, and still do, and as any thinking person believes who views the natural world on its own, that humanity must be

reigned in in order to keep it from fatally poisoning the earth. The whole thing must be managed for sustainability: population growth must be halted, resource use must be sustainable, and waste products must be recycled. Standing in the way of that are those exercising their freedom to create and develop and use resources and those who have a vision of the world informed by religion. So the key to sustainability is replacing individual freedom with managed economies. This is why we see medical experts taking advantage of a novel virus to cripple individual freedom. The medical experts have been handed the power to do this by a public that demands "health care." These doctors have no fear of being called out for malpractice: they recommend social distancing to forestall herd immunity which will ultimately cause more deaths but most importantly will keep the fear alive until a mandatory vaccine becomes the ultimate eugenics tool for population control by plan and not by accident.

The end was in sight decades ago when the label "health care" replaced "hospital insurance." Though the thing technically remains insurance, the name gives the impression that the system will take care of one's health. Therefore it stands beyond reproach in the eyes of a public quite willing to obey doctor's orders even though it kills them. They even donate to cancer research which will never commit suicide by developing an official cure and will never admit that inexpensive but unpatentable cures already exist.

Behind the system that the public places their confidence in are the several interests vying for the privilege of running the world, saving the world (or their favored part of the world) from doom, meanwhile living in the glow of master-minding the world’s salvation. No doubt all of them are aware that religious traditions have stories about where the world is headed, and further that the only credible one is detailed in the world’s best-selling book. But they prefer themselves to the Savior, which the Bible predicted would happen. (God actually laughs at them, holds them in derision—Psalm 2.) The Bible also states emphatically that God’s plan will prevail.
